Life Membership Ron Bell

It was clear from the Life Membership nomination that Ronald Harry Bell clearly met all mandatory and highly desirable requirements, and it was evident that Ron had demonstrated loyalty to the Association, its members and to the Regiment for a period greater than 10 years whilst he was a member of the Committee.

Ron had been an excellent member of the RAAC during his service and this continued during his time with the Association and as a member of the Committee.

It was apparent, based on the written nomination and personal knowledge of Ron over many years, that the criteria for life membership had been obviously met.

Ron had been a first-class performer in all activities, including work, community and sport, and this continued whilst a member of the Committee.

The process for Life Membership of the Association provides a rigorous set of guidelines not only for the nomination but also for the evaluation process. The Life Membership Sub-Committee found that Ron clearly met all mandatory requirements, and this was endorsed by the Executive and Management Committees of the Association.

Personal Note by the Secretary

As an addendum, could I just add that behind every good man is an exceptional woman and in Dinga's case, this is Mary. If there was ever a case for sharing 'Life Membership' this would be it. Mary was extensively involved in the organisation and running of at least three (3) major reunions as well as providing significant support, including administrative, moral and technical, to Ron on a daily basis.









Life Membership Peter Rosemond

The life membership nomination for Peter Rosemond was not as clear cut as that for Ron Bell as Life Membership submission did not specifically address the criteria specified in the Life Membership Policy and Procedures.

However, after careful deliberation all members of the Life Membership Sub-Committee felt that Peter Rosemond satisfied the mandatory and highly desirable criteria with clarity regarding the Committee's views about paragraph 2b of the Policy and Procedures. Whilst Peter had not served in a specified appointment of the Committee or Executive of the Association, he has been continually empowered by the Committee to act on their behalf in a number of dedicated and difficult roles. The following general comments were made concerning the nomination and the subject of the nomination, Peter Rosemond.

- a. Peter had been an outstanding member of the Australian Army, of the RAAC. His unrelenting commitment to the Corps and to current and former members of the Corps have continued for many years after his retirement.
- **b.** Peter's leadership and advocacy has been sought, on numerous occasions, by the Executive of the Association to undertake delicate and difficult matters relating to the formal recognition of Coral-Balmoral, Binh Ba and Hammersley Veterans. Peter has also had an ongoing role on behalf of the 1 Armd Regt Association Executive in representing its interests and helping to mature the fledgling RAAC Corporation in a wide-ranging number of sensitive issues, particularly those related to culture and values of membership matters.
- **c**. Peter has, over many years, acted in a guiding and mentoring role for both former and current members (including Presidents) of the Executive and Management Committees.
- **d.** As a member of the RAAC Corporation Advisory Board, Peter has formally represented the views of the Executive and Management Committees of the Association, as well as current and former members of the Regiment, seeking their counsel where appropriate.
- **e**. All Sub-Committee members felt that Peter has provided an untiring commitment to the

Association, to the Regiment and to all former members of the Regiment in his endeavours working with the RAAC Corporation and Head of Corps to present cases to Defence Honours and Awards and to the Defence Honours and Awards Appeals Tribunal.



The Sub-Committee all agreed that Peter has acted as a representative for the Association, as an agent of the Executive; and as the Association's point of contact for a number of significant matters and activities over many years since his retirement as RSM of the Army. Peter has also worked sensitively in the background with dedication, providing frank and fearless advice to the RAAC Head of Corps, the Representative Honorary Colonel RAAC, and the 1 Armd Regt Association's Patron and Honorary Colonel. His value in this role, acting in the Association's Best interests, has been exceptional. All members of the Sub-Committee agreed that Peter Rosemond's continuous commitment and dedicated work, as an agent and advocate of the Association's Executive, met and indeed exceeded the requirements of paragraph 2b of the Policy and Procedures.

Secretary's Report

This issue of the Secretary's report covers the following issues:

- AGM outcomes

Membership Notes: At 16 March 2021, the Association has a total of 501 active members; an increase of around 125 since the AGM held on 14 July 2018 when the current Management Committee was elected.

The Membership Renewal process for 1 February 2021 is in full swing and as at 25 March 2021 170 members (77.8%) had renewed their memberships but 46 members had yet to renew. Some of this is caused by changes to either email or postal addresses. Hopefully, all members will be found in due course!

As previously reported, the Association does not have a Recruitment Management Manager and we are largely dependent on existing members to encourage their friends to join.

AGM Outcomes

After a frustrating couple of months of delays due to COVID, the decision was made to commence the AGM using Zoom videoconferencing technology. At 10.00 am (AEDT) the meeting opened over the internet with 28 persons in attendance; 27 of these were eligible to vote.

Pertinent points from the AGM included:

Association website).

- a. Financial reports had been submitted to Consumer Affairs Victoria (CAV),
- b. An additional issue with pricing of Q Stock had been identified and a decrease of \$480 in the loss for the previous financial year had been included in revised financial statements submitted to CAV,
- c. The Annual Report including financial statements for the financial year ended on 30 June 2020 had been distributed to all Association members in the week prior to Christmas,
- d. The election of Dean Martin (former ASM of the Regiment) as the Vice President,
- e. The re-election of Russ James as the Secretary as well as Graeme Unmack as Special Projects Two,
- f. The size of the Management Committee was not changed but vacancies existed for the Recruitment Manager as well as the Representative for the Australian Capital Territory (ACT),
- g. There were no changes to the existing State Representatives and Mick Payne volunteered to continue to represent the members of the ACT,
- h. Life Membership Nominations for Ron Bell and Peter Rosemond, CSC OAM were approved,
- i. A proposal to offer 'free membership for 12 months' for personnel leaving the Regiment on reposting or discharge was approved,
- j. A proposal to offer two (2) scholarships one educational and the other sporting per year for a value of \$500 was approved, and
- k. An option to include only those who were either Killed In Action, wounded in Action or Killed Accidently on Duty while posted to the 1st Armoured Regiment was adopted (the new Honour Roll is published on the



VIC

Dawn Service – restricted to 1,400 persons by invitation only.

On 24 March 2021 it was announced that a March with only 5,500 marchers had been approved. This was the number that the Victorian Branch of the RSL requested. It is expected that those wishing to attend will have to register (how is unknown) and further that marchers will not march behind unit or association banners. Further details to be provided by the Victorian Representation (lain Reynolds) when final details have been confirmed.

The Victorian Government is urging everyone to attend local RSL services.

N.S.W.

As at 25 March it seems that 10,000 is the limit for the Sydney March and all those intending to participate must register. Crowd sizes for other locations including RSL and Sub-Branches is restricted to 5,000. Further details to be distributed by the State Representative as these become available.

TAS

The ANZAC Day March and Commemorative Service for Hobart is still in the planning stages but is to proceed. However, those wishing to participate in the traditional Hobart ANZAC Day March and Commemorative service are required to register. SOUTH AUSTRALIA: The Australian Army's proposed reorganisation and expansion over the next five to eight years under the 2028 Army Objective Force plan includes some dramatic force multipliers including a new Armoured Brigade Combat Team based in South Australia.

Under the 2028 Army Objective Force structure, the in-service 1st Brigade will be split into two separate combat brigades with the 1st Brigade combat units currently based at the Edinburgh Defence Precinct near Adelaide in South Australia forming the nucleus of a highly capable heavily armoured Brigade Combat Team (BCT) with new regular and mixed regular reserve heavy combat manoeuvre elements.

Under the new arrangements, the existing 9th Brigade (a South Australian and Tasmanian based Army Reserve formation command structure) will transition to a Total Work Force structure with a regular 9th Brigade Headquarters raised to command and control the new combat units

The recently relocated from the NT, 1st Armoured Regiment (1AR) will form the nucleus of the 9th Combat Manoeuvre elements, retaining its current structure of a Headquarters Squadron, a Support Squadron, a Main Battle Tank Squadron (B Squadron) and two Combat Reconnaissance Squadrons (A and C Squadrons).

Scheduled acquisitions will see 1st Armoured Regiment's B Squadron replace its in service M1A1 SA Abrams and M88A2 HERCULES Armoured Recovery Vehicles with new or remanufactured M1A2C/D Abrams Main Battle Tanks and M88A3 HERCULES Armoured Recovery Vehicles acquired under Project Land 907 Phase 2 by mid decade.

The 1st Armoured Regiment's two Combat Reconnaissance Squadrons, A Squadron currently equipped with ASLAV Phase 3 Light Armoured Vehicles and a trials fleet of Hawkei Protected Mobility Vehicle - Light and B Squadron currently equipped with ASLAV Phase 3 Light Armoured Vehicles, will operate the new Boxer Block II Combat Reconnaissance Vehicle which will enter service from 2023 under Project Land 400 Phase 2.

The new 9th Brigade's primary fires long range fires capability will be delivered by the 9th Regiment Royal Australian Artillery (9RAA) which will be reassigned from its current role as the command structure for the Army Reserve's six geographically separated Light Batteries (operating the F2 81mm mortar and soon to transition to the M252A1 81mm mortar entering service), to be the first of two planned Protected Mobile Fires Regiments equipped with the AS9 Huntsman Self Propelled Howitzer and its partnered AS10 Armoured Ammunition Resupply Vehicles which will be acquired under Project Land 8116 and enter service from 2023/24.

The 9th Brigade Order of Battle (ORBAT) information available to A&NZD indicates that 9th Regiment Royal Australian Artillery will be a Total Work Force manning unit with both regular and reserve personnel.

The Edinburgh Defence Precinct based 7th Battalion Royal Australian Regiment (7RAR) will be reassigned from the 1st Brigade to the 9th Brigade under 2028 Army Objective Force structure but continue on as a mechanised infantry battalion.

Under the new arrangements, 7RAR will replace its in service M113AS4 Family of Armoured Vehicles with the next generation Infantry Fighting Vehicle (either the Rheinmetall KF41 Lynx Armoured Fighting Vehicle range or Hanwha Defence AS21 Redback Armoured Fighting Vehicle range) and variants, to be acquired under Project Land 400 Phase 3 and scheduled to enter service in the second half of the 2020s.

The currently serving 9th Brigade 10th/27th Battalion Royal South Australian Regiment (10/27RSAR) Army Reserve light infantry battalion will lose its attached 3rd Field Squadron Royal Australian Engineers and transition to a mechanised infantry battalion mounted in Land 400 Phase 3 Infantry Fighting Vehicles.

The 9th Field Squadron, a new full time Royal Australian Engineers element will be raised to support the new 9th Brigade, which will be rolled as an Assault/Manoeuvre Support Squadron and will re-equip with the M1150 Assault Breacher Vehicle (ABV) and the M1074 Joint Assault Bridge (JAB) under acquisition under Project Land 8160 (Under Armour Breaching & Bridging).

The 9th Brigade's existing Army Reserve 9th Combat Service Support Battalion (9CSSB) logistics unit and 144th Signals Squadron will be augmented with significant full-time personnel to support the 9 Brigade Operations while in Australia, but would be likely replaced by full time combat support/combat service support elements if every deployed into high intensity combat scenarios.

The future 2028 Army Objective Force 9th Brigade will constitute the Australian Army's first true armoured brigade combat team capacity raised since the 2nd World War with the capacity to launch and sustain offensive operations through dense and sophisticated defences against both a peer or near peer opponent.

The heavy new 9th Brigade combat manoeuvre structure will be offset by the 2028 Army Objective Force restructured Northern Territory based 1st Brigade which will be reorganised as a light rapidly deployable brigade combat team with a unit and equipment mix optimise for littoral, amphibious or air emplacement operations
